

FINANCIAL INCENTIVES

This document highlights the financial incentives that are available to qualifying providers.

PROGRAM	DESCRIPTION
Colorado Health Service Corps Extended Dental Loan Repayment Program	An overview for dental providers interested in extending their participation in loan repayment programs.
Colorado Health Service Corps Loan Repayment for Private Practice- REAP	An overview of the state loan repayment program for providers practicing in a private practice that offers a full scope of outpatient primary care services.
Colorado Health Service Corps Loan Repayment Program	An overview of the state loan repayment option for qualified primary care health professionals serving a health professional shortage area.
Colorado Health Service Corps REAP Approved Site	An overview of the requirements to become a CHSC approved site including HPSA scores, sliding fee scales and insurance coverage. Sites must be approved for providers to apply for loan repayment.
Colorado Health Service Corps Scholarship Program for Addiction Counselors	An overview of scholarship opportunities for addiction counselors (CAT, CAS, LAC). Applicants are required to provide services at a CHSC- approved site.
Colorado Health Service Corps Site Requirements	This provides an overview of the requirements to become a CHSC approved site including HPSA scores, sliding fee scales and insurance coverage. Sites must be approved for providers to apply for loan repayment.
Colorado Rural Health Center Loan Repayment Guide	Grid breakdown of all loan repayment options with award amounts and contacts.

PROGRAM	DESCRIPTION
CRHC Rural and Frontier Preceptor Tax Credit	Information on the \$1,000 tax credit for eligible primary care preceptors working in rural, or frontier designated counties.
National Health Service Corps Auto-Approved Sites	A comprehensive list of auto approved NHSC sites. An application is still required but can be submitted during any point in the year.
National Health Service Corps Loan Repayment Program	An overview of the requirements for primary care providers to apply for national loan repayment. Providers can submit for both state and national repayment but can only accept one award.
National Health Service Corps Loan Repayment Site Requirements	An overview of requirements to become a NHSC approved site including site types, HPSA scores, services offered and payment for service types. Sites must be approved for providers to apply for loan repayment.
National Health Service Corps Nurse Corps Loan Repayment Program	An overview of loan repayment program for RNs, APRNs and nurse faculty practicing in a critical shortage area. This program pays up to 85% of unpaid nursing related education debt.
National Health Service Corps Rural Community Loan Repayment Program	An overview of loan repayment program for health professionals providing SUD treatment in rural communities. Professional must practice at an approved SUD treatment facility.
National Health Service Corps Scholarship Program	This program awards scholarships to students pursuing primary care health professions training. In return, scholars must provide services in a HPSA designated area.

PROGRAM	DESCRIPTION
National Health Service Corps Students to Service Loan Repayment Program	An overview of the loan repayment program for students in their last year of medical, nursing, or dental school. In return, providers must serve three years at a NHSC approved site.
National Health Service Corps Substance Abuse Disorder Workforce Loan Repayment	An overview of loan repayment for professionals providing SUD treatment in underserved areas. Professional must practice at an approved SUD treatment facility.
