


Rural hospitals accounted for 4% of Colorado's Medicare wage-adjusted direct costs.

### **COST AND CHARGE IMPACT**

iVantage examined 233 DRGs common to both Colorado rural and PPS hospitals, and to all US hospitals. DRGs with less than 5 total cases were excluded.



If **Colorado PPS hospitals** charged the same rate as Colorado Rural Hospitals, there would be **\$2,471,435,175 less** in Medicare charges. If all **U.S. hospitals** charged the same rate as Colorado Rural Hospitals, there would be **\$155,479,999,160 less** in Medicare charges.






