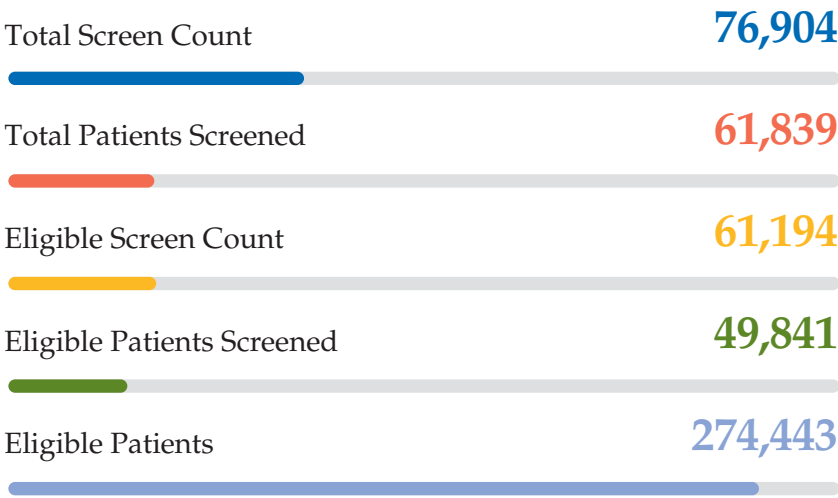


RURAL CONNECTIVITY PROGRAM DATA

Cancer Screening and Diagnoses

Cancer is the leading cause of death in rural Colorado. Through the Community Analytics Platform (CAP), facilities that participate in the Rural Connectivity Program can utilize various dashboards available in the Cancer Screening and Diagnoses Report to obtain valuable information about their facility’s unique patient population. Our Quality Improvement Specialists are here to assist your team with utilizing this data to make informed decisions about your cancer populations and improve patient outcomes.

The data below reflects cancer screening and diagnosis data for healthcare services from July 2023 - July 2024. Cancer data from the Colorado All Payer Claims Database (CO APCD) was provided by the Center for Improving Value in Health Care (CIVHC).



BREAST CANCER

Out of 108,049 patients who are eligible for the screen based on age and gender, 20,343 (18.8%) are up to date on the screening.

CERVICAL CANCER

Out of 81,029 patients who are eligible for the screen based on age and gender, 10,378 (12.8%) are up to date on the screening.

DEFINITIONS

Total patients screened refers to all patients that had a cancer screening including those who do not meet the routine screening recommendations (e.g. patients outside the age group but had screening ordered due to family history, symptomology, etc.).

Eligible screen count refers to the total number of cancer screenings done based on the recommended screening parameters. This number can be higher due to person(s) falling within more than one eligibility screening category that falls within the CDC age range.

Eligible patients screened denotes patients that fall within the eligibility parameters (based on screening recommendations) and have had a cancer screening completed.

Eligible patients refers to the total number of patients who are eligible for the actual recommended screening (e.g. Female assigned, between the ages of 25-65 is eligible for a cervical cancer screening).
